



**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT
AND AGREEMENT NOT TO PHOTO OR RECORD ("AGREEMENT")**

In consideration for, and as a condition to, Participation (as identified below) being permitted to enter, access and use the property located at Airsoft Tactical 1420 Armour St., East Ridge, TN 37412 (the "Property") and participate in certain activities on, or located at, the Property (collectively, the "Activities"), the undersigned on his or her behalf, or on behalf of his or her child or legal dependent, as applicable, and on behalf of his, her or its heirs, legal representatives and assigns (collectively, the Undersigned"), hereby acknowledges and agrees that Participant understands the nature of the Activities and is qualified, in good health and in proper physical condition to participate in such Activities. The Undersigned acknowledges and agrees that if Participant believes that any of the Activities or the Property is unsafe, Participant will immediately discontinue participation in the Activities and leave the Property.
